issue, we could not have imagined the scale of God's goodness in leading us to this national multi-denominational outcome.





MORTGAGE Story

CSS has a unique opportunity through the mortgage program to partner with Christian schools, churches, and charities, and see over time how God works through these groups.

In 2022 CSS renewed the mortgages of one such church, and the renewal process was a reminder of how much has been accomplished in the course of our long-standing relationship.

The connection began in 2011 when the thriving church requested a construction mortgage for building an addition to their facility to accommodate growth. CSS was happy to approve their application, and, based on that initial experience, the church leadership has actively referred other churches to CSS for mortgage financing.

Over the following years, the church tackled other intriguing projects. Land was severed to establish an affordable housing complex to meet key needs within the community. A subsequent severance, allowing another portion of the property to be sold to a housing developer, will generate significant revenue for the church which, in turn, opens up new opportunities for the congregation to invest in strategic worldwide mission projects. The housing development itself also strengthens relationships between the church and its community.

Proceeds from development will be used to repay the mortgage but, in the meantime, a new CSS mortgage has been approved to allow for significant renovations designed to improve the functionality and accessibility of the original church building.

In short, the past 12 years have been a challenging but fruitful adventure for the church, and CSS has been privileged to partner in this work. That partnership, of course, includes all CSS clients participating in the RDA & DAF programs from which the funds for these mortgages flow!
