



#### MORTGAGE INVESTMENTS WITH IMPACT A THRIVING CHRISTIAN SCHOOL IN QUEBEC

L'Ecole L'Eau-Vive is the *only* evangelical Christian school in the Quebec City region providing elementary and secondary school education. Since its inception as a private school in 2001, enrollment has grown steadily from 72 to over 400 students and it serves the families in over 40 local churches across various denominations.

However, the capacity of the school building didn't match the growth and there was concern that prospective students would be turned away. To ensure that quality education would continue, improved facilities were needed. CSS was pleased to work with the school beginning in 2017 to plan and provide mortgage financing for a significant addition with capacity for over 500 students and vastly improved facilities.

This story was not without its challenges: lofty fundraising targets, years of planning, and construction through Covid restrictions, but we write this story on the official opening date, April 7 2022!



We applaud the staff and volunteers at the School; our partner in Quebec, CQOC; the builder, consultants, and architect who were able to bring the project to completion considerably under budget; and CSS staffer Rob Vandebelt who has put much work and love into the project. What a wonderful success story and gift from the Lord to many generations!

CSS sees this mortgage as a truly strategic investment because the students - the next generation of the church in Quebec - are being uniquely equipped at L'Ecole L'Eau Vive:

- To learn about the Bible and Christian faith as part of the educational process
- To be supported by a healthy community through key development years and as they make some of the most important heart decisions of their lives
- To confidently interact with the broader community with a quality sports facility
- To experience the school as a hub, drawing separate and often small churches together, and
- To recognize that, though a minority in society, they are part of something much larger!



How do you measure the potential for future impact in each new graduating class equipped in this way? Who knows what God will do through the seeds planted in young lives at L'Ecole L'Eau Vive? What a privilege it is too that the CSS community, through funds provided by depositors, can be a partner in this great work!
